Designation of Airlines and Operation of Charter flights to Cyprus

With reference to the subject in heading and further to your letter ref. 9-4203 dated 07 November 2013, please be informed that the Aeronautical Authorities of Cyprus accept your suggestion to amend paragraph 2.4 of the Memorandum of Understanding on Air Services between Cyprus and the Russian Federation signed in Nicosia on 16th of March 2012 so as to allow double designation of scheduled carriers from Moscow and St. Petersburg to Cyprus.

Furthermore we accept your proposal to delete paragraphs 3.1 and 3.2 of the above mentioned Memorandum of Understanding thus enabling the operation of charter operations to continue without any coordination all year round.

We confirm that this letter and your letter dated 07 November 2013 constitute an agreement between the Aeronautical Authorities of the Russian Federation and Cyprus and shall come into force on the date of this letter.

We anticipate that the new arrangements reached today will act as catalyst to the increase in passenger traffic between our two friendly countries, which shows a robust growth in the last few years. The Aeronautical Authorities of Cyprus are looking forward to the designation of the second scheduled carrier from your side on the said routes. Furthermore with this letter the Aeronautical Authorities of Cyprus approve in advance all applications for the operation of charter flights from any point of the Russian Federation to Larnaca or Paphos International airports.

Dear Sir,

Aeronautical Authorities of the Russian Federation present its compliments to the Aeronautical Authorities of the Republic of Cyprus and wish to refer to your letter from 31st July, 2013 on the issue of extending the non coordination period for the operation of charter flights from Moscow and St. Petersburg to Cyprus and to explore the possibility to allow double-designation of schedule carriers from these two points.

The Russian side accepts your proposal and suggests amending paragraph 2.4 of the MoU of 16th March 2012 as follows: "Up to two (2) airlines can be designated from either side to operate scheduled flights on any given city - pair".

We also suggest making paragraphs 3.1 and 3.2 of the MoU null and void.

If our counterproposal is acceptable, your previous letter, your positive answer on this letter and this letter will constitute an agreement between the Aeronautical Authorities of Russia and Cyprus.

Operation of charter flights to Cyprus

I wish to refer to the subject in heading and to inform you that the Aeronautical Authorities of Cyprus wish to propose the extension of the period of non coordination for the operation of charter flights from Moscow and St. Petersburg to Cyprus and to explore the possibility to allow double designation of scheduled carriers from these two points.

The current arrangements concerning the operation of charter flights which were agreed earlier this year between our two countries, allow the operation of such flights for the period of 15th April to 31st of October of each calendar year. Since traffic between our two friendly countries continues to grow, it is preferable to allow charter operations to continue all year round.

Concerning the proposal for double designation from Moscow and St. Petersburg, I will appreciate your comments and your position on this issue.

Your response to this proposal will be highly appreciated. I remain at your disposal for any further clarification.
