Dear Mr. Lintzerakos,

The Department of State Policy in Civil Aviation of the Ministry of Transport of the Russian Federation presents its compliments to the Ministry of Infrastructure and Transport of the Hellenic Republic and would like to reassure its intention to strengthen contacts and cooperation between Aeronautical Authorities of the two respective countries.

In the scope of further development of air services between our countries, the Aeronautical Authorities of the Russian Federation would like to propose you to agree on the following by the exchange of letters:

On the route Moscow – Athens and v.v. the designated airlines of each Side will have the right to operate thirty five (35) frequencies per week.

These additional fourteen (14) frequencies will be allocated at the choice of each Side. For the Russian side seven (7) additional frequencies shall be utilized by the first designated air carrier and remaining seven (7) additional frequencies shall be utilized by the second designated air carrier.

If this proposal is acceptable for your Side, I have the honor to propose to consider this letter and your positive reply as an agreement between the Aeronautical Authorities on the abovementioned issue.
